- b. table draft resolutions for items included in the agenda of the AGM

The request to put items on the agenda of the general meeting or the draft resolution referred to above shall be submitted to the Company in hard copy form or in electronic form to [investor\\_relations@go.com.mt](mailto:investor_relations@go.com.mt) and shall be authenticated by the person or persons making it. The Company shall not be obliged to entertain any requests by shareholders after the 9 April 2021.
